The proposal was based on a discount off catalog or retail pricing rather than item-by-item. A committee of Mark Pantel, Director of Purchasing, Sue Betts, Assistant Director of Athletics, David Raffield, AMCHS Athletic Coordinator and Steve Huff, CSHS Athletic Coordinator evaluated each proposal and provided vendor award recommendations using an evaluation matrix.

It is the recommendation of Mark Pantel, Director of Purchasing and Sue Betts, Assistant Director of Athletics to award the Athletic Supplies RFP #14-009 to the vendors listed above effective June 1, 2014 through May 31, 2015 for an approximate expenditure of \$500,000 per year. This RFP may be renewed one (1) additional year if agreed upon by both parties sixty (60) days prior to expiration.
