Subject: Consideration, discussion and possible action regarding paid meal prices for the 2014-15 school year

### Background

The Healthy, Hunger-Free Kids Act of 2010 reauthorized the National School Lunch Program. One of the provisions of the act affects the prices schools must charge for their paid meals. Specifically, schools must charge the difference between the reimbursement rate for a free meal and the reimbursement rate for a paid meal. In CSISD, free lunches are reimbursed \$2.93, while paid meals are reimbursed \$0.28. So, for a paid school lunch CSISD must charge an average of \$2.65 for our lunches (rounded down to the nearest \$0.05). Districts that charge lower than that rate, like CSISD, must increase the lunch prices annually until they reach their target.

Currently, CSISD charges our paid students an average of \$2.15 per lunch for elementary students and \$2.40 for intermediate and secondary students. Secondary lunches cost more than elementary lunches due to the additional food choices and larger portion sizes. The Texas Department of Agriculture provides a formula each year to determine if a district must raise prices, and by how much. Based on that formula, CSISD must raise our lunch prices by \$0.10. Non-student meal prices must cover the cost of the meals and have been increased \$0.25 for next year. Breakfast prices for students are not affected.

The proposed meal prices for 2014-15 school year are:
