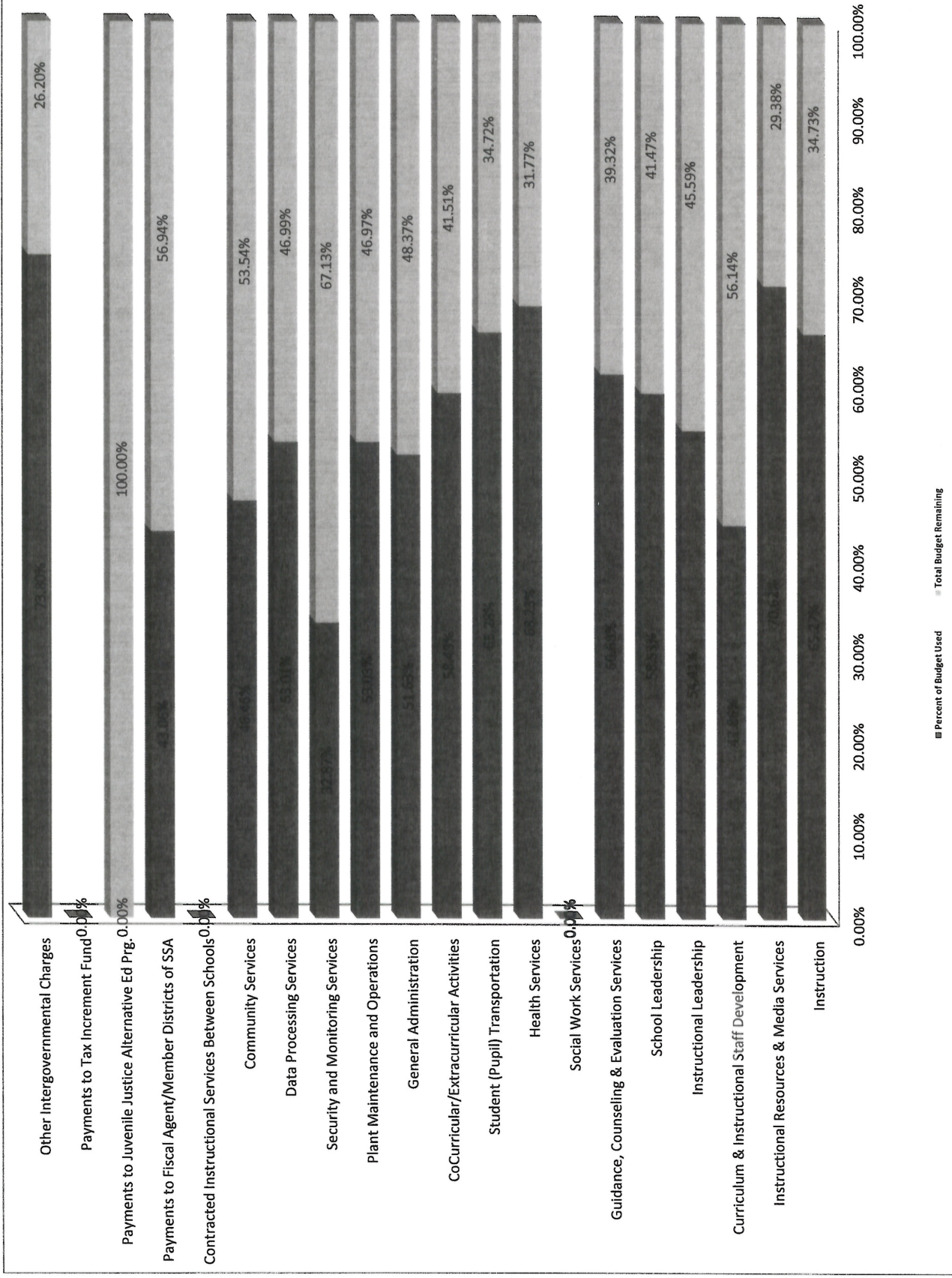

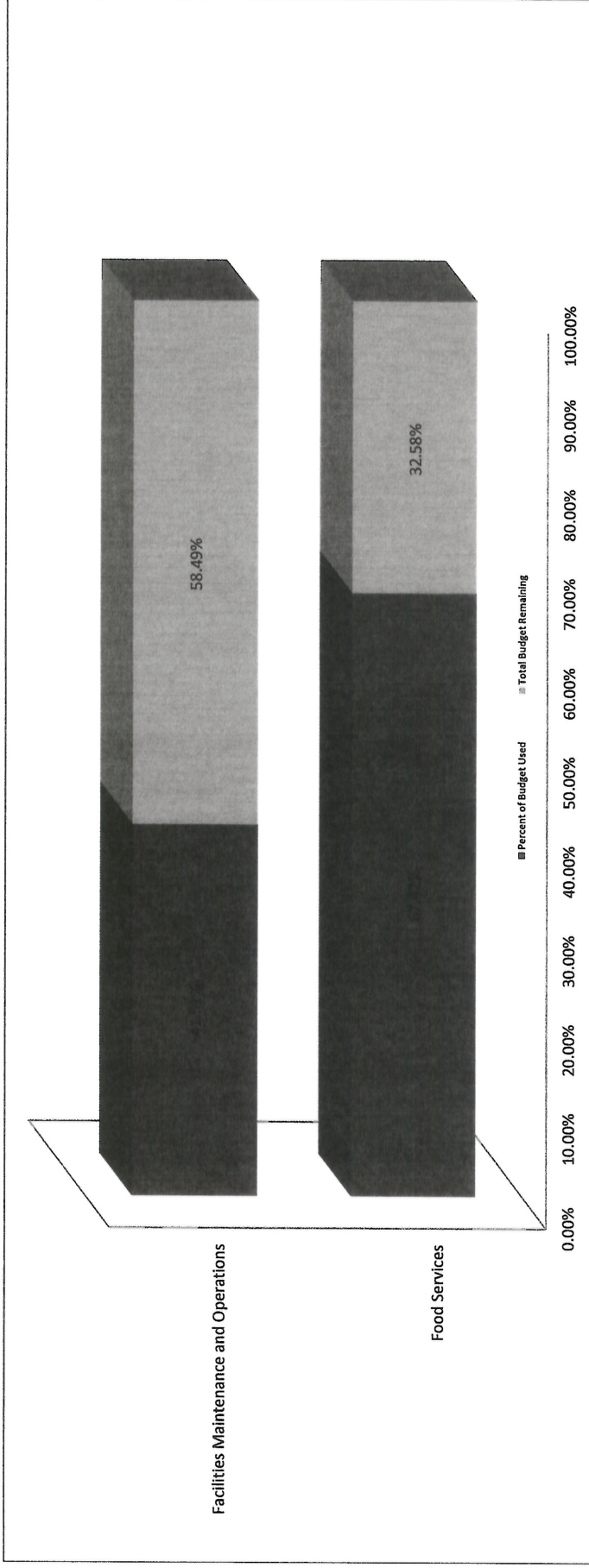
General Fund Remaining Budget Analysis

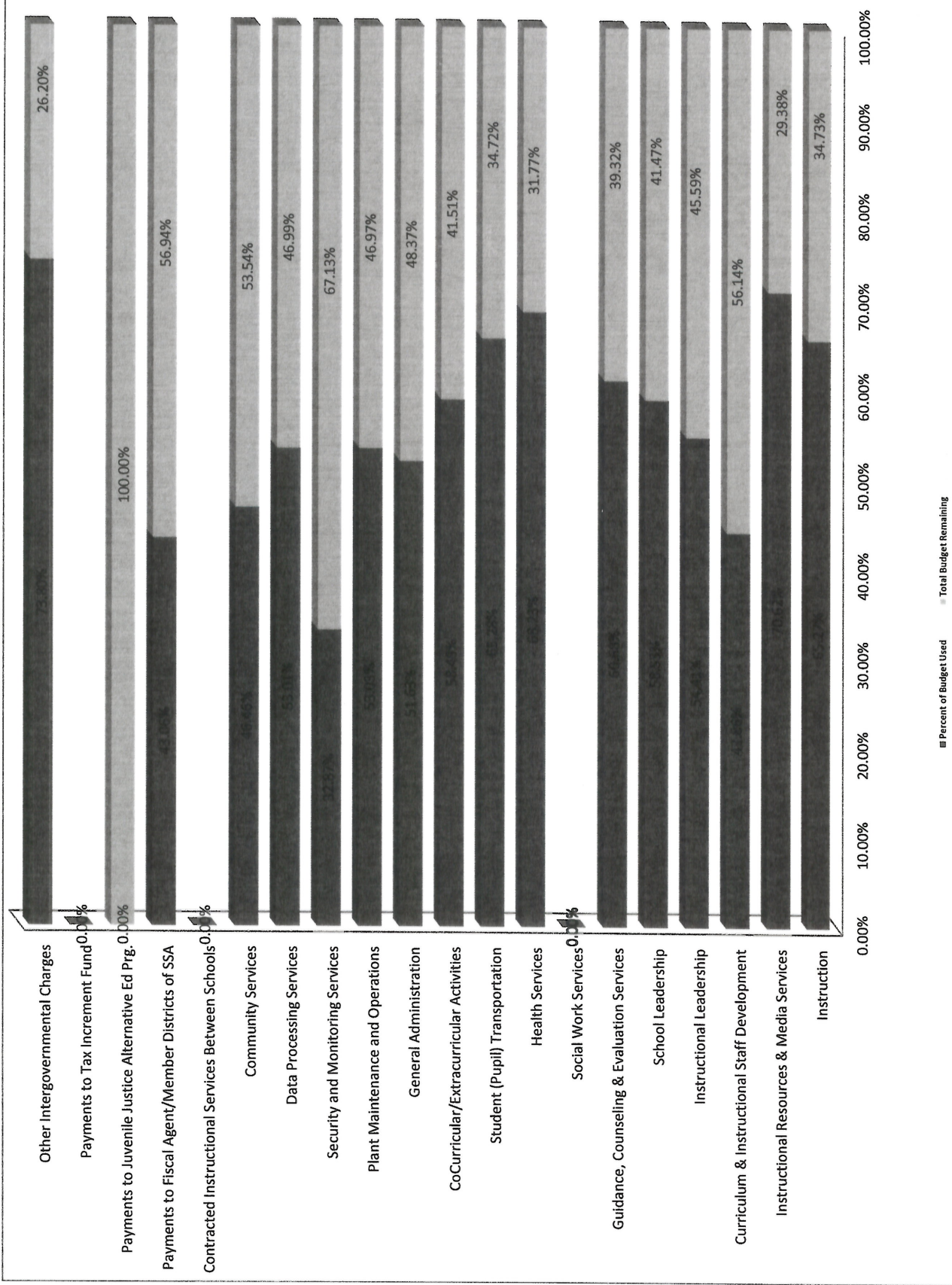

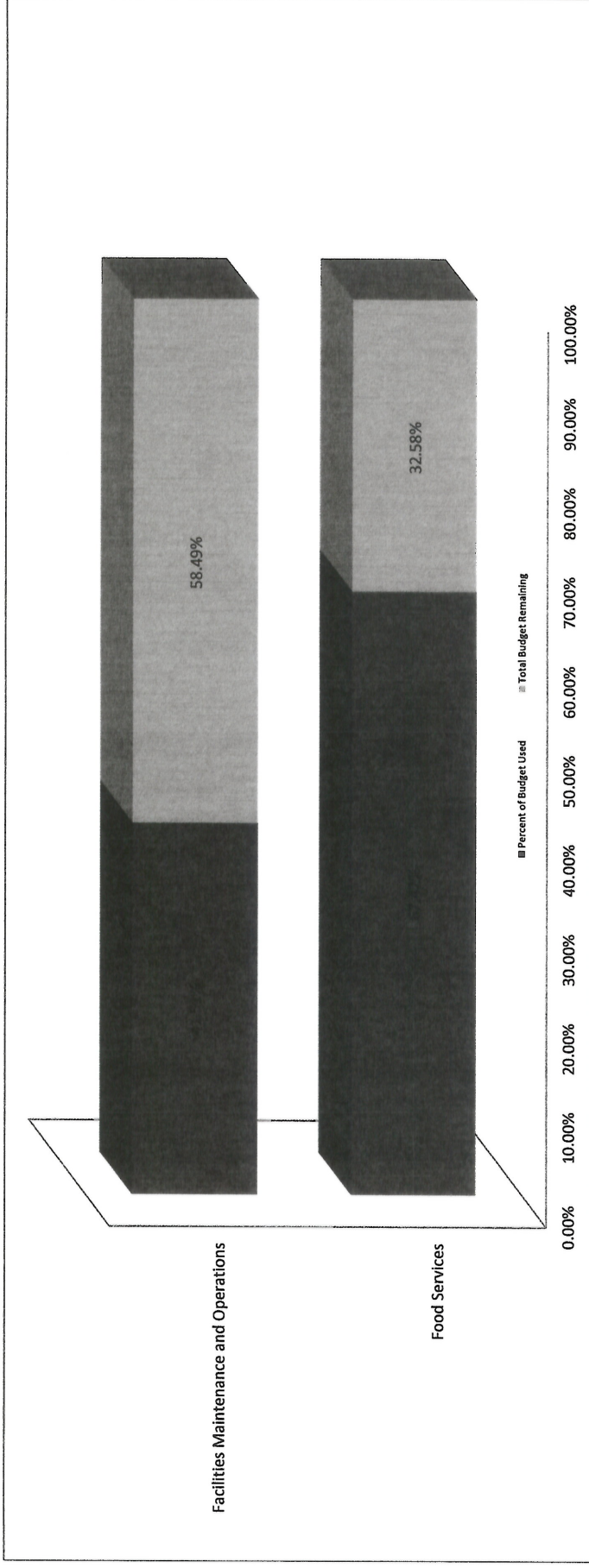
General Fund Remaining Budget Analysis
