SUBJECT: Purchases for School Resource Deputies (SRD)

College Station Independent School District recently entered into an agreement with Brazos County to supply five (5) School Resource Deputies (SRD) for the three high schools and the two middle schools beginning with the 2017-2018 school year. Included in this agreement is the purchase of five (5) law enforcement vehicles and related equipment by the district. The purchase of these vehicles was approved at the March board meeting.


The majority of the remaining equipment, technology and other services requested by Brazos County are available through contracts with the Department of Information Resources (DIR), Buy Board Cooperative, HGAC Cooperative and Brazos County. Contracts for these agencies and cooperatives have been competitively bid and meet the competitive bid requirements stipulated in Texas Government Code, Section 791.025.
