## BACKGROUND

Since 1986, the SBOE rule has required that a public announcement be made each year of the names of the board members who have completed the required continuing education hours and who are deficient. The annual required continuing education is a basic obligation and expectation of any sitting board member under State Board of Education rule. The president shall cause the minutes of the local board to reflect the information.

House bill 2563 passed in the 80<sup>th</sup> Legislative Session amended the TEC section 11.159 to include reporting board training hours at the last regular meeting of the calendar year.
