

SUBJECT: Roof Top Air Handling Units for Cypress Grove Intermediate

The Facilities Department has identified three (3) Roof Top Air Handling Units that need replacement at Cypress Grove Intermediate. These units are at the end of their service life.

A proposal was requested from Texas Air Systems to furnish these units per The Interlocal Purchasing System (TIPS) Purchasing Cooperative Contract #1032615 -HVAC Solutions and Services. College Station ISD is a member of this cooperative which is administered by Education Service Center (ESC) Region 8. All items have been competitively bid and awarded by the cooperative's Board of Trustees based on state statutes.

It is the recommendation of Mark Pantel, Director of Purchasing and Jon Hall, Executive Director of Facilities to purchase (3) AAON Roof Top Air Handling Units for Cypress Grove Intermediate from Texas Air Systems for \$89,155.00 per TIPS Contract #1032615.

The intent would be to order this unit immediately after the school board meeting in February and have it installed by Facilities Department staff prior to classes resuming in August. The funds for this purchase will be provided from 2013 Bond Deferred Maintenance funds.
