Description

Region 6 Education Service Center offers all phases of driver education on-site and through an online classroom for high school students through the following options. Your district's scheduled option is located under "Fee Heading."

OPTION #1

Semester Credit Classroom Phase 1 with Simulation & In-Car Phase 2: *Fee: \$405.00 per student*

Option 1 consists of 56 hours of Classroom Instruction, 12 hours of Simulation Instruction, 4 hours of Behind-the-Wheel Instruction and 4 hours of In-Car Observation. Option 1 is taught during the school day and students may receive 1/2 elective credit. The ideal classroom size for the semester course would be 18-24 students per class to operate the program. The Drug and Alcohol Driving Awareness Program (DADAP) can be added to the classroom instruction for an additional \$35.00 per student. This certificate will qualify a student to apply for the 5% insurance discount with their insurance company. The insurance discount would be for three years if accepted by their insurance company.

OPTION #2

Non School Credit Classroom Phase 1 with Simulation & In-Car Phase 2: *Fee: \$405.00 per student*

Option 2 consists of 32 hours of Classroom Instruction, 12 hours of Simulation Instruction, 4 hours of Behind-the-Wheel Instruction and 4 hours of In-Car Observation. Option 2 can be taught after school and/or during the summer. The Drug and Alcohol Driving Awareness Program (DADAP) can be added to the classroom instruction for an additional \$35.00 per student. This certificate will qualify a student to apply for the 5% insurance discount with their insurance company. The insurance discount would be for three years if accepted by their insurance company.

OPTION #3

Simulation & In-Car Phase 2: *Fee: \$350.00 per student*

Option 3 Simulation & In-Car Phase 2 consists of 12 hours of Simulation Instruction, 4 hours Behind-the-Wheel Instruction and 4 hours of In-Car Observation. Students must be at least 15 years old with a learner license/permit to complete the Behind-the-Wheel phase. (Classroom Phase 1 can be conducted by the District, Online, or TDLR Parent Taught Course 106) Option 3 can be taught during the school day, and/or after school and/or during the summer.

OPTION #4

Simulation Phase 2: Fee: \$115.00 per student

Option 4 consists of 12 hours of Simulation Instruction. The 12 hours of simulation instruction reduces the required 7 hours of Behind-the-Wheel to 4 hours Behind-the-Wheel. (Classroom and the In-Car Phase conducted by the District) Option 4 can be taught during the school day, and/or after school and/or during the summer.

OPTION #5

Non School Credit Classroom Phase 1: Fee: \$150.00 per student

*Option 5 consists of 32 hours of Classroom Instruction Only. Option 5 can be taught after school and/or during the summer. The Drug and Alcohol Driving Awareness Program (DADAP) can be added to the classroom instruction for an additional \$35.00 per student. This certificate will qualify a student to apply for the 5% insurance discount with their insurance company. The insurance discount would be for three years if accepted by their insurance company. After completion of the classroom hours, the student's classroom hours will be transferred to complete the **Laboratory Phase 2** (In-Car driving portion) through the following; **School District - Licensed Driving School - TDLR Parent Taught Program** - The Parent Taught Course 106 Curriculum will be provided for the completion of the Behind-the-Wheel phase through TDLR Parent Taught Program at a discounted fee of \$60.*

OPTION #6

"Online" Non School Credit Classroom Phase 1: Fee: \$100.00 per student

Option 6 consists of 32 hours of Online Classroom Instruction.

*This option can be taught after school and/or during the summer in a designated computer lab at the district or the student can sign up and take the online course on their own at home. After completion of the classroom hours, the student's classroom hours will be transferred to complete the **Laboratory Phase 2** (In-Car driving portion) through the following; **School District - Licensed Driving School - TDLR Parent Taught Program** - The Parent Taught Course 106 Curriculum will be provided for the completion of the Behind-the-Wheel phase through TDLR Parent Taught Program at a discounted fee of \$60.*

It is understood that Region 6 ESC will provide vehicles, simulator and instructional personnel as needed to operate the above programs. The school district can provide the classroom instructor as a benefit to their district and will need to have the driver education endorsement. The district will furnish a classroom, adequate space for the simulator and an electrical power supply for the simulator. The district will schedule the appropriate number of students per period.

Region 6 ESC intends to conduct the above programs at the stated price; however, circumstances may arise such as an increase in fuel, insurance prices, availability of cars, number of enrolled students and/or instructors that could cause Region 6 ESC to vary from the program and/or price.

Students must be at least 15 years old to obtain a learner license for the Phase 2 Behind-the-Wheel Instruction. Students must be enrolled in a public or licensed school and have attended school for at least 80 days in the fall or spring semester preceding the first day of class; or students must be enrolled for at least 45 days and currently enrolled in a program to prepare persons to pass the high school equivalency exam "Texas Certificate of High School Equivalency" (TxCHSE).

Description

What is the Texas Student Data System (TSDS)?

TSDS is a major initiative by the Texas Education Agency (TEA) to modernize and improve the quality of data collection, management, and reporting in Texas Education. It is TEA's vision for an enhanced statewide longitudinal data system that will streamline the local education agency (LEA) data collection and submission process; equip educators with historical, timely, and actionable student data to drive classroom and student success; and integrate data from preschool through postsecondary school for improved decision making.

TSDS Training:

Training is implemented using the Train-the-Trainer model. TEA provides training and guidance to ESCs and the ESCs then train key staff at LEAs. The LEA staff that received training are then responsible to train additional LEA staff and campus users. TEA depends on the ESCs' training and support expertise and relationship with the LEAs to make this initiative a success. Training will be offered in the following areas.

- TSDS Unique ID
- studentGPS® Dashboards
- TSDS PEIMS (Public Education Information Management System)
- TSDS Technical
- TSDS TEAL (Texas Education Agency Login)
- TSDS ECDS (Early Childhood Data System)

Please note that additional areas may be added as TEA develops further requirements and functionality.

TSDS Support:

In order to manage the support for a system as large and diverse as TSDS, TEA has developed an incident management system, which will route all incidents to the appropriate support staff, track their outcomes, and retain a history of the problems users are having. Once an incident has been created it is sent to the appropriate LEA contact. If the LEA contact cannot resolve the issue it is then escalated to an ESC contact. If the ESC contact cannot resolve the issue it is then escalated to TEA support.

TSDS Training & Support Fees:

Support fees include training provided locally at Region 6 ESC or via a webinar session.
