A proposal was requested from Texas Air Systems to furnish a one for one replacement unit per The Interlocal Purchasing System (TIPS) Purchasing Cooperative Contract #1032615 -HVAC Solutions and Services.

College Station ISD is a member of this cooperative which is administered by Education Service Center (ESC) Region 8. All items have been competitively bid and awarded by the cooperative's Board of Trustees based on state statutes.

It is the recommendation of Mark Pantel, Director of Purchasing and Jon Hall, Executive Director of Facilities to purchase a 40 ton AAON roof top air handling unit for \$71,420.00 from Texas Air Systems per TIPS Contract #1032615. This total includes a \$1,480 deduction for the Wattmaster Control which is not required.

The funds for this purchase will be provided from the 2013 Bond Deferred Maintenance budget. The intent would be to order this unit immediately after the school board meeting in June and have it installed by Facilities Department staff prior to classes resuming in August.
