This RFP is for Facility Maintenance Plumbing Services to be used to supplement Facilities Department plumbing personnel on an as needed basis. Each bidder was asked to quote hourly rates for the various classes of plumbing maintenance labor and a percentage mark-up for materials purchased for a specific maintenance project. The quantities of hours listed in the RFP were annual estimates provided for bid evaluation purposes only. The Hourly Rates Total is the sum of the hourly rates based on the estimates provided.
