budget, authorization for the Superintendent or his designee to execute the necessary documents associated therewith, and the authorization to proceed with the work associated with the renovation of the South Knoll Elementary School,

AMCMS and CSMS campuses.

BACKGROUND

In November 2015, College Station ISD voters passed a bond issue for \$135.9 million for new construction and renovation to district facilities. One of the major projects identified from this bond package was for the renovation of interior spaces at South Knoll Elementary School. This agenda item represents the work related to preparing the Guaranteed Maximum Price (GMP) and total project budget for the final phase of work at South Knoll Elementary School and some additional work at the AMCMS and CSMS campuses. Funding for this work is from 2015 Bond Deferred Maintenance funds.

The GMP for this project was based on the Request for Competitive Sealed Proposals (RFCSP) process. The RFCSP has been advertised to the public as required by statute. The Construction Manager at Risk, Pepper Lawson Construction coordinated the competitive sealed proposal process for this work. Jon Hall, Executive Director of Facilities and Theo Rouse, Coordinator of Construction Services were present for CSISD as the proposals were received and tabulated on December 18, 2018.

The scope of work includes the second phase of the renovations to South Knoll Elementary School which provides new flooring, paint, millwork, interior signage and some exterior upgrades to the building facade. The work also includes the first phase of renovation at the two older middle schools, which provides new flooring, paint, interior signage, and other minor interior upgrades in the public areas which do not include classrooms. The actual construction of this work would be scheduled for the summer of 2019.

RECOMMENDATION

It is further recommended that the Superintendent or his designee be authorized to sign any necessary documents to implement the Guaranteed Maximum Price and that the Board of Trustees authorizes the commencement of the work associated with this project.
