SUBJECT: STEMscopes Science Instructional Online Resources

New math and science instructional materials were adopted across the state in 2014. During that adoption for Proclamation 2014, College Station ISD adopted teacher materials only for grades K-4 and textbooks for students in grades 5-8. Since that time, our district has evaluated our data and recognized a need for additional resources for teaching science.

The additional resources recommended by Amanda Gibson, Coordinator of Science in 2017 included STEMscopes for grades K-8. The resources associated with STEMscopes included lab activities, online resources, and consumable kits for labs for each teacher and classroom for grades K-8. In 2018 the district purchased only the online resources for K-8. In 2019, the district will continue using K-8 online with the addition of Biology and Chemistry online resources for the high schools.

After evaluating the district's use of these materials, an additional year of the online resources is being requested by the Curriculum Department as well as the addition of the online resources for Biology and Chemistry for the high schools. STEMscopes is the publisher and sole source provider of these materials at this time. Funds to purchase one year of online resource can be requested from TEA through an Instructional Materials Allotment (IMA) disbursement request.

It is the recommendation of Carmella Shafer, Director of Purchasing and Penny Tramel, Chief Academic Officer that we request these funds from TEA and purchase the online resources from STEMscopes for K-8 Science classrooms plus Biology and Chemistry for the high schools for \$75,687.50 for the 2019-2020 school year.
