BACKGROUND

After the renovation of the back area of the Central Office building and the subsequent move of several departments, the Community Education Department is next in need of some renovation work. A significant piece of work that must be done prior to any upgrading of this area is the removal of a large concrete vault located in the center of their current office space. Upon removal of the vault and the reconfiguration of some their current space, the efficiency of the layout of their office space can be much improved with this renovation.
