SUBJECT: Roof repairs at A&M Consolidated High School

As part of the 2013 Bond program, the Facilities Department has worked with L.D. Tebben Company on a solution to fix several trouble spots on the roof at A&M Consolidated High School including metal roof items that were identified in a roof assessment report conducted by Armko.

The attached proposal from L.D. Tebben Company is to provide labor and materials to make numerous roofing repairs including removing part of an exterior brick wall that is failing. This portion of brick wall will be replaced with R-panel and metal studs.

L.D. Tebben Company has been awarded the Roofing and Waterproofing Services Contract #17-038CG-11 by the Choice Partners Purchasing Cooperative of which the district is a member. This cooperative is administered by the Harris County Department of Education (HCDE) and all items have been competitively bid and awarded by the cooperative's Board of Trustees based on state statutes.

It is the recommendation of Mark Pantel, Director of Purchasing and Jon Hall, Executive Director of Facilities to purchase the labor and materials to make numerous repairs to the roof and replace an exterior brick wall with Rapanel and metal stude at A&M Consolidated High School from L.D. Tebben Company for \$158,362.00 per Choice Partners Contract #17/038CG-11. This is a 2013 Bond Deferred Maintenance item.

- f) Remove and replace approx. 400 ln. ft. of caulk joints at windows on multiple roofs.
- g) Remove debris from roof and clean around all drains.
- h) Install metal cap over chiller lines.


