SUBJECT: NWEA MAP Test (Measures of Academic Progress) Online Resources

The core purpose of our work as an educational institution is student learning. To better measure how and to what degree our students are learning and growing across campuses and grade levels, it is necessary to evaluate performance using valid and reliable instruments. Results should be readily accessible to teachers, parents, and administrators to inform instructional practices and provide transparency about the effectiveness of instruction.

The Northwest Evaluation Association (NWEA) is a nonprofit organization specializing in the assessment of students. The MAP Test (Measures of Academic Progress) creates a personalized assessment experience by adapting to each student's learning level and precisely measuring progress and growth for each student. This computer-based assessment is designed to be administered at the beginning, middle, and end of each school year. This assessment system provides educators with immediate feedback about students' strengths and learning needs, as well as a clear understanding of how students are progressing academically. After careful consideration, the MAP online resource was purchased and first implemented in 2019-20 for grades K-8 to meet these identified needs. This purchase would continue the use of MAP during the 2020-21 school year.

The recommended purchase includes MAP Reading Fluency for grades K-2 and struggling readers in grades 3 and up, as well as MAP Growth for grades K-8. MAP Reading Fluency assesses oral reading fluency, reading comprehension, and foundational reading skills. MAP Growth assesses Math and Reading in grades K-8, and includes Science for grades 3-8.

These online resources are available from North West Evaluation Association (NWEA) through the Choice Partners Contract #18-058KC-23. All items on this contract have been competitively bid and awarded by the Cooperative's Board of Trustees based on state statutes.

It is the recommendation of Carmella Shafer, Director of Purchasing and Molley Perry, Chief Administrative Officer that CSISD purchase the MAP online resources for \$144,393.00 per the Choice Partners Contract CP #18-058KC-23 for the 2020-2021 school year using general funds.
