SUBJECT: Renewal of Hoonuit Data Warehouse Software License

In October 2015, a committee of district and campus-level administrators came together to search for a software platform that would allow for quick and easy access to state and local assessment data, grades, attendance, and background data with the capability to generate reports on various subgroups of students. The best system would be one that the district could customize input and show data in multiple ways and from multiple sources.

Hoonuit (formerly Mizuni) fully integrates with eSchool, the district's current student information system, and can incorporate locally created data and provides a seamless solution to our student data management needs. In 2020, Hoonuit LLC was acquired by PowerSchool, our SIS provider.

PowerSchool's Hoonuit product is available per the Sourcewell purchasing cooperative contract 090320-POW. Sourcewell's contracts have been competitively bid and meet the competitive bid requirements stipulated in Texas Government Code, Section 791.025.

It is the recommendation of Carmella Shafer, Director of Purchasing, and David Hutchison, Director of Technology that the district renew the Hoonuit software license for 2021 (01/15/2021-01/14/2022) from PowerSchool for \$63,130.08 to be paid from 2020-21 general funds.
