A. CALL TO ORDER

President Jeff Horak called the meeting to order at 5:00 p.m.

B. DECLARATION OF QUORUM / WELCOME

President Horak declared a quorum with seven members present. In attendance were President Jeff Horak, Vice President Joshua Benn, Secretary Thomas Hall, Trustee Blaine Decker, Trustee Kimberly McAdams, Trustee Geralun Nolan and Trustee Darin Paine.

C. HEARING OF CITIZENS

1. Public comments regarding agenda items will be heard at this time. There were no citizens wishing to address the board at this time.

D. WORKSHOP SESSION

1. Consideration, discussion and possible action related to naming TASB delegate and alternate for 2022 Texas Association of School Boards Delegate Assembly

Trustee Kimberly McAdams was the delegate for CSISD last year. Over the past few months she has been a part of the TASB Legislative Advisory grassroots process. It was recommended by TASB that she continue to represent CSISD as a delegate, but we do need an alternate. Trustee Geralyn Nolan volunteered to be the alternate.

As a reminder, the TASA/TASB Convention will be held on September 22-25 in San Antonio.

<u>MOTION 5018</u>: So moved. The motion was made by Vice President Joshua Benn and seconded by Secretary Thomas Hall. The motion carried with seven ayes and zero nos.

- 2. Consideration and discussion regarding TASB Policy Update 119
 - Molley Perry, Deputy Superintendent/CAO gave a brief overview of TASB Policy Update 119.
- 3. Consideration and discussion regarding recommended updates to Policy FNCE (Local)
 - Deputy Superintendent Perry reviewed information regarding Policy FNCE (LOCAL) regarding tracking devices for students and the use of such devices to protect the privacy of other students in the classroom while allowing parents the option to use said devices. This would prohibit the listen in capability from being turned on while at school. Discussion occurred.
- 4. Consideration, discussion and possible action related to the 2022-23 budget and tax rate
 - Amy Drozd, CFO, <u>reviewed</u> the proposed budget and tax rate for the 2022-2023 school year. This will be reviewed again at the Public Hearing tonight at 6:40 pm and again at the regular meeting at 7:00 pm as an action item. Discussion occurred.
- 5. Consideration and discussion regarding the 2022 assessment and accountability results

Deputy Superintendent Perry <u>reviewed</u> the 2022 assessment and accountability results. It was 2019 when the last accountability ratings were issued. There were and continue to be, issues from TEA and the vendor, Cambium, on reporting accurate results. Overall, CSISD showed gains across the board at the higher standards. Math instruction was more impacted by the pandemic than were other subjects. CSISD's overall accountability rating was a B with 89%. Discussion occurred.
