A. CALL TO ORDER

President Jeff Horak called the meeting to order at 5:30 p.m.

B. DECLARATION OF QUORUM / WELCOME

President Horak declared a quorum with seven members present. In attendance were President Jeff Horak, Vice President Joshua Benn, Secretary Geralyn Nolan, Trustee Blaine Decker, Trustee Thomas Hall, Trustee Kimberly McAdams and Trustee Darin Paine.

D. WORKSHOP SESSION

1. Review November 7, 2023 election results and related timelines

Superintendent Dr. Tim Harkrider reviewed the election results from the November 7, 2023 bond election. The canvass of election results will be done at a meeting at noon tomorrow. Prop A passed by 70% and Prop B passed by 62%. Prop C and D did not pass. Thank you to the voters for passing the largest bond in the history of the district. Thank you also to the PAC committee and the bond planning committee for all of their efforts and to the Cabinet members for doing sixty-five presentations across the district. Dr. Harkrider would like to reconvene the planning committee to discuss continued needs and possible next steps. The need to continue to educate members of the community on the educational pieces, true needs and benefits of adequate athletic facilities is critical and will be a focus. Discussion occurred. As a reminder, bonds cannot be used for compensation.

2. Consideration and discussion related to the 2024-2025 school calendar development process

Tiffany Parkerson, Executive Director for Secondary Education, <u>presented</u> information on the calendar development process. The DEIC met to develop calendar options in October. Survey feedback was gathered through this morning and will be analyzed based on priorities for academics, student and educator wellness, educator development and frequency, timing & length of breaks. The State requires 76,500 instructional minutes, which equals about 170 full school days. Teachers are on a 187 day teacher calendar. Discussion of semester breaks start & end times, length and frequency of breaks and major breaks aligned with TAMU and Blinn College continue to be high priorities.

3. Receive a report on the English as a Second Language and Emergent Bilingual programs

Patty Ayala, Director of Special Programs, gave a <u>presentation</u> on the English as a Second Language and Emergent Bilingual programs as required by law. Clarifying questions were asked and answered.
