Amy Drozd, Chief Financial Officer, and Chris Neely, Director of Business Services jointly reviewed the 2023 Financial Management Report based on the 2021-2022 fiscal year and overview of the Schools FIRST (Financial Integrity Rating System of Texas) System and most recent rating for College Station Independent School District. CSISD scored a 98 out of 100. CSISD passed all four critical indicators, by filing the annual financial report on time, receiving an unmodified opinion, being compliant with debt payments and making all payments timely to TRS, IRS, and other governmental agencies.

The remaining solvency and ceiling indicators were reviewed with explanations of the data elements. CSISD passed all ceiling indicators. The required disclosures including the Superintendent contract, and reports of any gifts, reimbursements and business transactions between the district and the Superintendent as well as Board Members was also mentioned as required supplemental information. Clarifying questions were asked by the Board.
