How long has your church been organized in our community?

We have held Sunday services for eight months, meeting at the College Station Conference Center.

What is the size of your congregation and its growth rate?

We began with six people last August and currently have about twenty active members. We foresee growing to 35-45 for the 2004/2005 school year. If good growth trends continue we could be at 50-70 membership for 2005/2006.

What are the long range plans for your church?

Our long range plans are to be a multigenerational, multiethnic church which impacts TAMU, the BCS community, the United States, and the world.

To facilitate the realization of this vision, we plan to generate numerous small groups--called "Light Groups"--which meet on campus and in various parts of the twin city area. (The purpose of these groups is to grow people spiritually and reach out beyond the "walls" of the church.)

Additionally, our long range plans include a training system to equip members for ministry in other United States cities and across the globe. In the future, we expect to send people out to begin new churches in other university towns, as well as minister cross-culturally in international settings.
