This contract made this the ^{16th} day of April 2007, by and between TEXAS VOTING SYSTEMS, INC., a Texas Corporation, and the CITY OF COLLEGE STATION, County of Brazos, State of Texas.

WITNESSETH:

Whereas, Texas Voting Systems, Inc. is the business of selling election services and supplies; and

Whereas, the CITY OF COLLEGE STATION is desirous of employing the services of TEXAS VOTING SYSTEMS, INC. in connection with the CITY OF COLLEGE STATION MUNICIPAL ELECTION, COLLEGE STATION ISD ELECTION AND BRAZOS COUNTY SPECIAL ELECTION to be held on May 12, 2007 in Bryan, Brazos County, Texas;

Now, Therefore, in consideration of the premises and mutual promises and obligations herein set forth, it is agreed that:

I

TEXAS VOTING SYSTEMS, INC. will provide the following supplies:

- (a) Twenty (20) election sets to include the early voting canvassing board and one central counting station set .
- (b) All required seals for the voting devices.

II

TEXAS VOTING SYSTEMS, INC. will provide the following services:

- (a) Review programming.
- (b) Assist with pre-election training
- (c) Load and pre-define eSlates, DAU's and JBC's
- (d) Back up and reset eSlates, DAU's and JBC's
- (e) Assist with Early Voting as required
- (f) Assist with Official Test as required
- (g) Assist on election day, as required to include the central counting station
- (h) Deliver and pick up equipment for Early Vote and Election Day voting
- (i) Provide any consulting services before and after the above-mentioned election.
- (j) Assist with recount of certain precincts

III

The CITY OF COLLEGE STATION, County of Brazos, State of Texas, will be responsible for, and hereby assumes the following duties and obligations in regard to the CITY OF COLLEGE STATION MUNICIPAL ELECTION to be held on May 12, 2007:

- (a) Rental or loan of the voting equipment and central counting tabulating equipment and other needed equipment from Brazos County.
- (b) Payment of all invoices, Election Judges, Alternate Judges, and Clerks of Election, to include the Central Counting station staff.
- (c) Furnish Texas Voting Systems, Inc. a complete list of all candidates, races and issues to be voted on in the above mentioned election.
- (d) All reports, expense accounts, canvass of the election, conduct of the election at the individual polling places and any other statutory requirements as required by the Texas Election Code and/or the Federal Voting Rights Act.

IV

The consideration to be paid by THE CITY OF COLLEGE STATION to TEXAS VOTING SYSTEMS, INC. for the services and supplies to be rendered provided by said corporation for the CITY OF COLLEGE STATION MUNICIPAL ELECTION, COLLEGE STATION ISD ELECTION AND BRAZOS COUNTY SPECIAL ELECTION to be held on May 12, 2007 is TEN THOUSAND FOUR HUNDRED FIFTY DOLLARS AND NO CENTS (\$10,450.00)


