

The proposal was based on a discount off catalog or retail pricing rather than item-by-item. The catalog method of bidding allows an award to multiple vendors and provides a larger product and supplier base for Athletics. A committee of Sue Betts, Assistant Athletic Director, David Raffield, AMCHS Athletic Coordinator and Steve Huff, CSHS Athletic Coordinator evaluated each proposal and provided vendor award recommendations using a bid evaluation form.

It is the recommendation of Mark Pantel, Director of Purchasing and Sue Betts, Assistant Director of Athletics to award the Athletic Supplies RFP #12-003 to the vendors listed above effective June 1, 2012 through May 31, 2013. This RFP may be renewed one (1) additional year if agreed upon by both parties sixty (60) days prior to expiration.
