

## Interlocal Agreement – School Resource Officer

### Agenda Item:

Consider approval of an Interlocal Agreement between the City of College Station (“**City**”) and College Station Independent School District (“**CSISD**”) for the purpose of continuing the School Resource Officer Program between the City and CSISD.

### Motion and Resolution

On motion made and seconded, it is hereby resolved that:

- A. **WHEREAS**, Chapter 791 of the TEXAS GOVERNMENT CODE, also known as the INTERLOCAL COOPERATION ACT, authorizes all local government entities to contract with each other to provide a governmental function or service that each party to the contract is authorized to perform individually and in which the contracting parties are mutually interested; and
- B. **WHEREAS**, College Station Independent School District (“**CSISD**”), and the City of College Station (“**City**”) are local government entities, each acting by and through their duly authorized agents (collectively, the “**Parties**”); and
- C. **WHEREAS**, the Parties have sufficient funds available from current revenues to perform the functions contemplated by this agreement; and
- D. **WHEREAS**, the City has established a School Resource Officer Program (hereinafter “SRO”), with law enforcement officers from College Station Police Department (hereinafter “CSPD”) and
- E. **WHEREAS**, the Parties recognize the outstanding benefits of the SRO Program to the citizens of the City and to the students of CSISD; and
- F. **WHEREAS**, it is in the best interest of the Parties and the citizens of the City and students of CSISD to continue the SRO Program;
- G. **WHEREAS**, the parties have prepared an Interlocal Agreement (“ILA”) attached hereto as Exhibit “1” and incorporated for all purposes herein, which sets forth the terms of the SRO program.
- H. **WHEREAS**, the City and CSISD have agreed this ILA would mutually benefit each Party and would further their governmental purpose; and
- I. **WHEREAS**, CSISD, pursuant to the authority granted under Chapter 791 of the Texas Government Code desires to participate in the described agreement offered by the City, and is of the opinion that participation will benefit the school district, and the community.

ON MOTION, DULY MADE AND SECONDED IT IS HEREBY RESOLVED THAT:

1. The terms and conditions of the ILA, and any other documents necessary to effectuate the ILA, have been received by the Board of Trustees of CSISD and found to be acceptable and in the best interest of CSISD and its citizens, and are hereby in all things approved.
2. The Board further resolves that the ILA as approved by this resolution is in conformity with the Texas Government Code, including provisions of Chapter 771 et. seq., and Chapter 791, et. seq.
3. The Board further authorizes the Superintendent or Board President and his or her agents and assigns to execute this ILA and any other documents necessary to effectuate the ILA.
