BACKGROUND

At the November 2019 College Station ISD School Board Workshop, Texas Association of School Boards (TASB) Policy Update 114 was presented for discussion. This update provides legal and policy updates as recommended by TASB.

Update 114 focuses almost exclusively on legislation from the 86th Regular Legislative Session. Several local policies have been updated to better align with these changes, as well.

Legal policy updates are governed by current law or court rulings; therefore, College Station ISD must include them in school board policy by statute. Local policy updates are designated to provide clarification on legal policies and provide appropriate discretion as decisions are made regarding the school district. Policies impacted by this update include the following:
