SUBJECT: Renewal of Mizuni Data Warehouse Software License

A committee was formed in 2015 to look at several different vendors that supply Student Data Management Warehouse Applications. Based on the evaluation, the committee agreed that Mizuni was the best solution for the district and recommended the purchase.

The district's current student information system, eSchool is provided by PowerSchool. After discussions regarding the district's student data management needs with PowerSchool, they were able to provide third party software from Mizuni, a preferred partner, as a seamless solution to our student data management concerns. Mizuni fully integrates with eSchool and can incorporate locally defined data.

In April 2019, Hoonuit LLC acquired Mizuni inc. We are purchasing the renewal using Central Texas Purchasing Alliance (CTPA) RFP# 11392. College Station ISD is a member of the Central Texas Purchasing Alliance which allows us to use other member districts awarded bids.

It is the recommendation of Carmella Shafer, Director of Purchasing and David Hutchison, Director of Technology that the district renew the Data Warehouse License Software for 2020 in the amount of \$61,300.00 to be paid from 2019-20 general funds.
