#### D. WORKSHOP SESSION

 Consideration, discussion and possible action related to a Management Oversight Workshop for the CSISD Human Resources Department

This presentation included information on our new clinical teaching program. The early resignation incentive was a huge success and helped tremendously with early hiring.
