A. CALL TO ORDER

C. MEETING SESSION

1. Discussion and possible action on board policies and Board Operating Procedures regarding citizen comments

President Horak addressed the hearing of citizens from the previous regular meeting that had not been encountered prior to that time. As a result, the board discussed proposed changes to the Board Operating Procedures regarding citizen comments as recommended by CSISD's legal council. After much discussion, a motion was made by Trustee Blaine Decker to table the first recommendation to have legal counsel provide us with more options. Further discussion occurred and there was no second made. Subsequently, Trustee Decker withdrew his motion. Discussion continued.

<u>MOTION 5185</u>: I would like to move that we update the procedures portion of our Board Operating Procedures as described in the second paragraph of the proposed Operating Procedures as presented. The motion was made by Secretary Joshua Benn and seconded by Vice President Dr. Darin Paine. The motion carried with seven ayes and zero nos.
